Miscellaneous Fees	Other fees covered by separate ordinances may also apply such as water and street impact fees, sewer pro rata fees, sewer tap, water tap, meter and box fees, driveway/curb cut fee, certificates of occupancy (fire-safety inspection), etc. These fees are due when the building permit is issued (except fire-safety inspection) and will be calculated and added to the building permit fees if applicable. All fees shall be collected on each permit, as applicable. If permit fees are paid by check and the check is returned for insufficient funds the permit will be considered invalid and void.
